#### 50/50 Campaign for Democracy – Gender Audit Report European Elections 2009: Most Political Parties Lagging Behind in the Road towards Gender Equality!

The EWL 50/50 Campaign for Democracy, running since September 2008, has published a Gender Audit Report in light of the European elections 2009. The Gender Audit looks at political programmes and electoral lists for the European Parliament (EP) elections in June from a women's rights perspective. It evaluates the political parties' commitment to gender equality in view of the EP elections 2009 and encourages voters to be involved in European politics. This report shows that most political parties do not consider equality between women and men as a key priority despite the strong competence of the European Union in the area.

The EWL Gender Audit analyses the available electoral manifestos of four of the main European political parties: the European People's Party (EPP), the Party of European Socialists (PES), the European Liberal Democrat and Reform Party (ELDR) and the European Greens. Rather than focusing on the general track record or of representatives of the parties, the audit concentrates exclusively on their 2009 European elections manifestos. It must also be noted that priorities might vary between a party at the European level and its national member parties.

The results of the review of the content of European electoral manifestos give the EPP a **RED** light; the ELDR a **RED** light; the GREENS a YELLOW light and the PES a **GREEN** light. These results were based on the importance the manifestos give to four issues that the EWL sees as relevant for the realisation of equality between women and men including for example issues of reconciliation of private and working life or violence against women.

While reviewing the **composition of the electoral lists of national political parties** for the 2009 elections, we looked at the general percentage of women on the lists, but also more specifically, at the **percentage of women heads of lists**, given the fact that it might very well be that a party has a list with the same number of women and men, but that women are placed towards the end of the lists. The review shows that in 17 countries, there are more women on the lists than the current % of women Members of the European Parliament. However, looking more accurately at where women are placed as heads of lists, there are only seven countries where this occurs. The current representation of women in the European Parliament for the four political groups reviewed gives a good indication of the commitment of these groups to the promotion of women in decision-making. For the 2004-2009 legislative period, the **Greens had the highest percentage of women with a very near parity 47.6%**, followed by the Socialist **Group (41.2%) the Liberals (40.4%) and finally the Group of the EPP with only 24.03%**.

## Elections européennes 2009: la plupart des partis politiques en retard sur la route vers l'égalité femmes-hommes!

La Campagne 50/50 pour la démocratie du Lobby européen des femmes (LEF) en cours depuis septembre 2008 a publié un rapport d'audit examinant les élections européennes de 2009 dans la perspective des droits des femmes! Notre audit porte sur les programmes politiques et les listes électorales pour les élections européennes de 2009 du point de vue des droits des femmes. Il évalue l'engagement des partis politiques envers l'égalité femmes-hommes en vue des élections du Parlement européen de 2009, et encourage les électeurs-trices à participer à la politique européenne. Ce rapport montre que la plupart des partis politiques ne considèrent pas l'égalité entre les femmes et les hommes comme une priorité, malgré la forte compétence de l'UE dans ce domaine.

L'audit du LEF analyse les manifestes électoraux disponibles de quatre des principaux partis politiques européens: le Parti populaire européen (PPE), le Parti des socialistes européens (PSE), le Parti européen des libéraux démocrates et réformateurs (ELDR) et les Verts européens. Sans examiner le bilan général des partis ou de leurs représentant-e-s, l'audit se concentre exclusivement sur leurs manifestes en vue des élections européennes de 2009. Il faut aussi noter que les priorités peuvent varier entre un parti au niveau européen et ses partis membres au niveau national.

# Les résultats de l'examen du contenu des manifestes électoraux européens donnent un feu ROUGE au PPE ; un feu ROUGE aux libéraux / ELDR ; un feu JAUNE aux Verts et un feu VERT au PSE.

Ces résultats sont fondés sur l'importance que les manifestes donnent à quatre questions que le LEF considère comme pertinents pour la réalisation de l'égalité entre les femmes et les hommes, notamment la conciliation de la vie professionnelle et de la vie privée ou la violence envers les femmes.

L'audit se penche également sur la présence des femmes sur les listes électorales, y compris en tant que têtes de liste. L'étude montre que dans 17 pays, il y a plus de femmes sur les listes pour 2009 que l'actuel pourcentage de femmes eurodéputées. Toutefois, en examinant plus précisément si les femmes sont placées en têtes de liste, il y a seulement sept pays où cela se produit. La représentation actuelle des femmes au Parlement européen pour les quatre groupes politiques examinés donne aussi une bonne indication de l'engagement de ces groupes à la promotion des femmes dans la prise de décision. Pour la période législative 2004-2009, les Verts ont le plus haut pourcentage de femmes avec un chiffre de 47,6% très proche de la parité, suivis par le groupe socialiste (41,2%), les libéraux (40,4%) et enfin le Groupe du PPE, avec seulement 24,03%.

#### Update on the EWL 50/50 Campaign - www.5050democracy.eu

The EWL 50/50 Campaign "No Modern European Democracy without Gender Equality" was launched on 16.09.08. The European wide Campaign aims to increase the presence of women at the highest level of European politics and to encourage women to cast their votes in the next

European elections. The Campaign is already personally endorsed by a number of well known personalities from across Europe (see 50/50 website here).

#### National Campaign activities

- Austria: the EWL member organisation Österreichischer Frauenring organized a 50/50 Campaign event on 11.05.2009, entitled "Frauen wählt – EUROPÄISCHE DEMOKRATIE BRAUCHT FRAUEN" ("Women Vote! European Democracy needs Women!"). The event took place in the information office of the European Parliament in Vienna, with the participation of MEPs and women candidates.
- **Denmark** A seminar on women and the European Union was organized by the Danish Women's Council in Copenhagen on 02.05.2009. There were three presentations in the morning and a panel with candidates to the European Parliament as well as a speech by a feminist author in the afternoon. Gender equality, diversity and the European Union were discussed.
- **Finland:** the EWL Finnish coordination NYTKIS started a truck tour of "The European Movement in Finland", discussing gender equality and the European elections 2009 from 9 May to 6 June 2009 in several locations.
- France: the Regional Group for Action and Information for Women (Groupement Régional pour l'Action et l'Information des Femmes, GRAIF) led a support action for the 50/50 Campaign on 12.05.2009 in Marseille. The initiative presented a list of support in the Provence-Alpes-Côte d'Azur region. This list made up of 100 prominent persons, of whom 50 were women and 50 were men, from the political, cultural, artistic and sports areas, showing support for parity democracy in the European Union.
- **Greece:** the Greek coordination for the EWL organized on 29.04.09 a Press Conference and discussion event for the official presentation of their TV and radio spot, as well as of their pamphlet on the 50/50 Campaign for Democracy.
- **Portugal:** the Portuguese Platform for Women's Rights led several 50/50 activities from April to May including a public seminar entitled "Parity and political participation" organised in Lisbon on 15.05.09; a 50/50 TV spot; a 50/50 radio spot on the web page http://plataformamulheres.org.pt/ (at the button, where it says: o ficheiro áudio do spot -formato mp3). - Slovenia: The Slovenian Women's Lobby organized a series of 8 public discussions with women candidates of all parties in the regions in March-April 2009. Furthermore, they have published 90.000 copies of the 50/50 Campaign material in the biggest daily Delo as well as information in Delo on what parliamentary parties promise on gender equality issues and on where they have placed their female candidates.
- Sweden: The European Commission, together with SKEN, the Swedish Women's lobby, organised a seminar on 09.05.2009 on the 50/50 Campaign with the participation of Margot Wallström. The target groups were young mothers and grandmothers.

#### European & International News in Brief

**The European Commission has referred Poland to the European Court of Justice (ECJ)** for non-transposition of EU rules prohibiting gender discrimination in access to and supply of goods and services (Directive 2004/113/EC). Poland has not yet adopted the necessary measures to give effect to the legislation in national law. Read more <u>here.</u>

**The Spanish Ministers Cabinet approved the draft of the new abortion law.** The draft gives free abortion until the 14th week, and to the 22nd week when there is a risk to the mother or an ill-formed foetus. Girls who are 16 will be able to decide themselves if they want to proceed, without parental consent. The news in Spanish can be <u>read here</u>.

#### News from the European Parliament

**Estrela report – Maternity Directive:** At the last plenary session of the European Parliament (6 May) Ms Astrid Lulling (Luxembourg) speaking on behalf of her political group - EPP - called for a referral back to FEMM committee of the Estrela report – which means that the new Parliament and new Women's Rights Committee will have to start afresh. Stating that there would be "chaos" (if allowed to vote) Ms Lulling, referring to number of amendments, said that this would not enable an "objective debate with the Council and the Commission". However, the EWL believes that had the vote been allowed, the report would have been adopted as the other political parties were favourable and the EPP was divided. The EWL is deeply disappointed by this decision as many of the proposals contained in the Estrela report mirrored the EWL's proposals to improve the rights of pregnant workers, women who have recently given birth and/or are breastfeeding. The contentious aspects of the report (for which amendments were tabled) related to the duration of maternity leave and especially pay during leave. The EWL will pursue the work with the newly elected Parliament in the autumn. Other Social NGOs gathered under the auspices of the Social Platform, which included the Confederation of Family Organisations -COFACE, Eurochild, the European Anti Poverty Network, and the European Disability Forum, worked together with the EWL to propose a shared vision (including textual amendments) for the equal rights for working women during pregnancy, on giving birth and while breastfeeding. Adoption by the EP of the Astrid Lulling report on "Equal treatment between men and women: self-employed workers and their spouses (repeal. Directive 86/613/EEC)" which is part of a co-decision procedure. The main proposals are particularly favourable to women including provisions for mandatory social security coverage for those that are assisting their life partners in self-employed activities and family businesses (including farm work); having social rights in their own name would make assisting spouses less vulnerable in the event of divorce, death of the self-employed partner or bankruptcy. Public Hearing about Women's rights in Turkey held by the EP Women's rights and Gender Equality Committee on 30.04.09. The need to protect women against violence and trafficking and to improve their educational opportunities were among the issues highlighted in the introduction to the hearing - titled "The role of women in Turkey in social, economic and political life" - given by MEP Emine Bozkurt (PES, NL), the author of EP reports on women in Turkey in 2005 and 2007.
